PROFESSIONAL BACKGROUND

Madeleine was admitted to the NSW Bar in 2016 and currently practices as a barrister in Sydney, Australia, in the areas of human rights, public law, commercial law and family law. She comes to law as a second career and brings with her significant experience having worked in the health and social care sectors for many years, specialising in mental health, drug and alcohol, domestic violence and child protection. Madeleine has published work in both national and international journals and presented at a number of conferences globally.

Madeleine was initially called to the Bar of England and Wales in 2011. Following her admission, she spent a year working in Nigeria for the Bar Human Rights Committee of England and Wales where she fearlessly advocated for the rights of children whilst actively promoting the rule of law. She trained NGO workers in legal case management and assisted lawyers in successfully prosecuting cases of child abuse, as well training UNICEF, the police and the judiciary across Nigeria. Madeleine then travelled to Strasbourg to work for the European Court of Human Rights having been awarded the Peter Duffy Human Rights Scholarship in 2010 by The Honourable Society of Lincoln's Inn. She was responsible for preparing draft reports and decisions on cases brought before the Court regarding admissibility. In 2010 and 2009, respectively, she was awarded the Head of School Prize and the Oxford Press Prize for best postgraduate law student, and in 2010 she was also awarded the Hardwick Entrance Scholarship by The Honourable Society of Lincoln's Inn.
